Adjournment unanimously took place at 3:44 p.m.





- Completed before new Niagara Official Plan and changes to Provincial legislation and planning policies
- Based on significant community engagement
- Addressed local issues and priorities including unique agricultural system of NOTL
- Completed before several local plans and strategies




Official Plan Update - Drivers

- 3. Local Priorities




Driver #1 Niagara Official Plan Conformity


- 2051 planning horizon and growth forecasts
- Conforms to Growth Plan, 2020 and Provincial Policy Statement, 2020
- Became an official plan of the Town on March 31, 2025
- Intent to incorporate mandatory NOP policies and mapping into NOTL OP and repeal NOP upon approval of NOTL OP by Minister
- Contains important updates such as new Natural Heritage System, watershed planning and climate change policies



Driver #2

Provincial Planning





- Provincial Planning Statement, 2024 combined and replaced the Growth Plan, 2020 and Provincial Policy Statement, 2020
- Prescriptive Growth Plan policies replaced by more general policy direction
- Policy changes on growth forecasting, growth management, agricultural systems approach etc.




PPS Environmental Policy Changes



- Municipalities must use "natural heritage systems" approach to map, based on provincial guidance, but <u>not</u> provinciallymapped Growth Plan NHS – no impact in NOTL as it is entirely Greenbelt Plan NHS
- Encouragement for watershed planning to inform planning for servicing and SWM infrastructure
- 'Watershed planning' definition added
- Municipalities encouraged to work with conservation authorities in watershed planning
- Planning authorities shall plan to reduce GG emissions and prepare for impacts of a changing climate




NOP Environmental Conformity Review



- Incorporate mapping and policies of the natural environment system into OP and zoning by-law in a manner that implements the NOP
- Responsible for preparation of sub-watershed studies and implementing sub-watershed plans through development review process
- Climate projections must be considered by the local municipality in land use policies, strategies and guidance
- Mapping of Natural Environment System linkages, buffers
- Address permitted and prohibited uses adjacent to key natural heritage /key hydrologic features and areas
- Address permissions for small-scale agricultural or residential buildings in vegetative protection zones, buffers and adjacent lands, w/o EIS
- Address Special Policy for Tender Fruit and Grape Area in Greenbelt Plan



Next Steps



- Engagement Period (April May)
 - Town Advisory Committees Agricultural, Environmental, Heritage
 - Indigenous communities
 - Community groups/ resident associations
- Draft Official Plan to Council/release for public engagement (June)
- Engagement Period (July August)
- Public Open Houses/Statutory Public Meeting (September)
- Adoption of new Official Plan by Council (October/November)
