#### 4. PUBLIC MEETING

# 4.1 File - OPA-1-2024 - Character Study Official Plan Amendment - CDS-24-029

Director of Community and Development Services Kirsten McCauley introduced the Character Study and Tim Smith from Urban Strategies.

Tim Smith from Urban Strategies presented the Character Study.

Due to technical difficulties Council recessed at 6:27 p.m.

Council resumed at 6:31 p.m.

Tim Smith from Urban Strategies resumed his presentation.

Mr. Smith answered questions of clarification from Council.

Elizabath Masson, 322 Simcoe Street - author of a four part series on the history of the Rand Estate that was published in the Lake Report in 2021, spoke about the heritage features including the Randwood wall and the importance of maintaining it, the garden around the Rand swimming pool was designed in approximately 1925 and the importance of maintaining horticultural features, proposed Council invite Mr. Marotta to donate the property to the Town.

Gracia Janes, 261 King St - On behalf of the Niagara-on-the-Lake Conservancy - expressed that the protective recommendations are hindered by the development of a subdivision, concerned with the intensification of the area and the need to protect the heritage attributes, believes this decision will set a precedent regarding Cultural Heritage, Landscapes and Environmental Heritage Resources in the Town

Dana Anderson, 12 James Street North - presented on behalf of Save Our Randwood Estate (SORE) - expressed that the study, the process, and the recommendations have been extremely well done, requested minor edits related to the proposed OPA that was in a letter sent to Council and requested clarification related to the axial walkway. Recommended that the Official Plan Amendment proposed with the edits be adopted as an amendment to the current Official Plan and be forwarded to the Region prior to approval.

David Riley, Partner at SGL Planning and Design, - 1547 Bloor St. West - presented on behalf of Two Sisters Resorts Corp, which are the owners of 144 and 176 John St, as well as Solmar Niagara - confirmed the study and the proposed OPA will not apply to the existing applications and appeals at

these addresses, noted that the outcome of the OLT Hearing could impact the draft policies that are proposed in the OPA. Requested that Council defer any decision on the OPA until after the OLT decision on the current applications and appeals.

Councillor Vizzari lifted item 9.1 Information Report Character Study Official Plan Amendment - OPA-1-2024 - CDS-24-029 for discussion.
