## THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE BY-LAW NO. 4316DM(1)-24

A BY-LAW TO AMEND BY-LAW NO. 4316DM -19, BEING A BY-LAW TO AMEND BY-LAW 4316-09, AS AMENDED, ENTITLED A BY-LAW TO REGULATE THE USE OF LAND AND THE CHARACTER, LOCATION AND USE OF BUILDINGS AND STRUCTURES THEREON.

**WHEREAS** the Town of Niagara-on-the-Lake Council is empowered to enact this By-law by virtue of the provisions of Section 34 and Section 36 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended;

**AND WHEREAS** the Town of Niagara-on-the-Lake Council did approve By-law 4316DM-19 on April 8, 2019 which included a Holding ("H") Symbol in accordance with Section 36(1) of the *Planning Act* that prevents the development of the Lands until the Holding ("H") Symbol is removed;

**AND WHEREAS** the Owner of the lands has now met the requirements for removal of the Holding ("H") Symbol from the lands;

**AND WHEREAS** Section 36(4) of the *Planning Act* provides that a Holding ("H") Symbol may be removed by passing a By-law applying to the lands subject to the Holding ("H") Symbol.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN
OF NIAGARA-ON-THE-LAKE enacts as follows:

1. Section 1 of By-law 4316DM-19 is amended by deleting the symbol "-H" and the word "holding" in "Established Residential (ER-91A-H) - site-specific zone-holding".

2. Section 3 (7.14.91 and 7.14.91.1) of By-law 4316DM-19 is amended by deleting all references to the symbol "-H" throughout the Section.


3. Section 3 (7.14.91.4) of By-law 4316DM-19 is deleted in its entirety.

4. Map "A" attached to and forming part of By-law 4316DM-19 is deleted and replaced with Map "A" attached to and forming part of this By-law.

5. That this By-law comes into force and takes effect immediately upon the passing thereof.
