TOWN OF NIAGARA-ON-THE-LAKE

BY-LAW NO. 5157B-23

A BY-LAW TO AMEND BY-LAW 5157-19 AS AMENDED, BEING A BY-LAW REGULATING HEAVY VEHICLE TRAFFIC ON HIGHWAYS UNDER THE JURISDICTION OF THE TOWN OF NIAGARA-ON-THE-LAKE.

WHEREAS the Council of the Corporation of the Town of Niagara-on-the-Lake approved By-Law 5157-19 on the 5th day of May 2019;

AND WHEREAS Section 11 of the Municipal Act, R.S.O. 2001, Chapter 25, authorizes the Council of a Municipality to pass By-Laws respecting highways, including parking and traffic on highways;

AND WHEREAS Municipalities may pass By-Laws under the provisions of the Highway Traffic Act, R.S.O. 1990, c H8;

AND WHEREAS on April 9th, 2019 Council adopted a resolution to implement Heavy Vehicle Restrictions on certain streets in the Historic Old Town;

AND WHEREAS Council considers it desirable and necessary to amend the definition of a "Police Officer" to include Municipal By-Law Enforcement Officers;

AND WHEREAS Council considers it desirable and necessary to add definitions for "Drive", "Move", "Operate", "Park", "Stand" and "Stop";

AND WHEREAS Council considers it desirable and necessary to include penalties and fines for the contravention of By-Law 5157-19 as amended (Heavy Motor Vehicle By-Law) under By-Law 4744-14 as amended (the Administrative Penalties By-Law);

AND WHEREAS Council considers it desirable and necessary to amend Schedule "A" (Heavy Motor Vehicles Prohibited) attached to By-Law 5157-19 to include all streets located north of Picton Street and east of King Street;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN

OF NIAGARA-ON-THE-LAKE enacts as follows:

1. That Section 2.2.3 of By-Law 5157-19, being a by-law to regulate heavy motor vehicle traffic on highways under the jurisdiction of the Town of

Niagara-on-the-Lake (the "Heavy Motor Vehicle By-Law") be repealed and replaced by the following definition:

- 2.2.3 "Police Officer" means each of;
 - i. a Municipal Law Enforcement Officer;
 - ii. a person authorized by Council with the responsibility for enforcing and administering the Administrative Penalties and Fines By-Law, the Parking and Traffic By-Law, the Private Property Parking By-law, the Fire Route By-Law and/or the Heavy Motor Vehicle Prohibition By-Law; and
 - iii. a police officer employed by the Niagara Regional PoliceService, the Niagara Parks Police, the Ontario ProvincialPolice or the Royal Canadian Mounted Police.
- 2. That Section 2.2 of By-Law 5157-19 as amended, be amended by adding the following definitions:

"Drive or Driving" has the same meaning as in the Highway Traffic Act.

"Move or Moving" has the same meaning as in the Highway Traffic Act.

"Operate or Operating" has the same meaning as in the Highway Traffic Act.

"Park or Parking" has the same meaning as in the Highway Traffic Act.

"Stand or Standing" has the same meaning as in the Highway Traffic Act.

"Stop or Stopping" has the same meaning as in the Highway Traffic Act.

- 3.. That Section 3.1 of By-Law 5157-19 as amended, be repealed and replaced with the following:
 - 3.1 When authorized signs are on display, no person shall:
 - 3.1.1 Drive, move or operate a heavy motor vehicle with a RGW over 3,000 (kg) on any highway under the jurisdiction of the Town where said highway is named or described and set out in Schedule A to this by-law and any amendments hereto.
 - 3.1.2 Stop, stand or park a heavy motor vehicle with a RGW over 3,000 (kg) on any highway under the jurisdiction of the Town where said highway is named or described and set

out in Schedule A to this by-law and any amendments hereto.

- 4. That Sections 6.1, 6.2 and 6.3 of By-Law 5157-19 as amended, be repealed and replaced with the following:
 - 6.1 Any fine imposed pursuant to Section 3.1.1 of this by-law is subject to the provisions of the Provincial Offences Act. All other fines imposed or offences created by this By-Law shall be subject to the provisions of By-Law 4744-14, being a By-Law to establish a system of administrative penalties and administrative fines (the "Administrative Penalty By-Law") and the system of administrative penalties and fines established therein.
- 5. That Schedule "A" (Heavy Motor Vehicles Prohibited) attached to By-Law 5157-19 be amended by adding:

- That Schedule "A" (Heavy Motor Vehicles Prohibited) attached to By-law 5157-19, is hereby deleted and replaced with Schedule "A" (Heavy Motor Vehicles Prohibited) as amended attached hereto;
- 7. This by-law shall come into force and take effect immediately upon the passing thereof except where signs must be erected and public notice given, in which case the signs must be erected, public notice period completed and the by-law finally passed before those clauses shall come into effect.
