### **CORPORATION OF THE**

#### TOWN OF NIAGARA-ON-THE-LAKE

#### **BY-LAW NO. 5334A-24**

A BY-LAW TO AMEND BY-LAW 5334-21, BEING A BY-LAW TO ESTABLISH AN ADMINISTRATIVE MONETARY PENALTY SYSTEM FOR NON-PARKING OFFENCES:

**WHEREAS** the Council of the Corporation of the Town of Niagara-on-the-Lake approved By-Law 5334-21 on the 21st day of June 2021;

**AND WHEREAS** sections 8, 9, 10 and 11 of the *Municipal Act, 2002, S. O. 2001, c.25*, as amended ("Municipal Act, 2001") authorize the Town of Niagara-on-the-Lake to pass by-laws necessary or desirable for municipal purposes;

**AND WHEREAS** section 434.1 (1) of the *Municipal Act, 2002, S. O. 2001, c.25,* as amended ("Municipal Act, 2001") provides that, a municipality may require a person, subject to such conditions as the municipality considers appropriate, to pay an administrative penalty if the municipality considers appropriate, to pay an administrative penalty if the municipality is satisfied that the person failed to comply with a by-law passed under this Act;

**AND WHEREAS** section 434.1 (2) of the *Municipal Act* provides that the purpose of a system of administrative penalties established by a municipality under this section shall be to assist the municipality in promoting compliance with its bylaws;

**AND WHEREAS** the Council of the Corporation of the Town of Niagara-on-the-Lake approved Idling Reduction By-Law 55nn-24 on January 30, 2024

AND WHEREAS the Council of the Corporation of the Town of Niagara-on-the-Lake considers it desirable to enforce and seek compliance with Idling Reduction By-Law 55nn-24 through inclusion in the Administrative Monetary Penalty System for Non-Parking Offences (AMPS Non-Parking) By-Law 5334-21;

NOW THEREFORE, THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE enacts as follows:
