Aimee Alderman, Senior Planner, gave a presentation on File ZBA-02-2024, 26T-18-24-02, 26CD-18-24-01 - Konik Estates P2.

William Heikoop agent for the application gave a presentation on Konik Estates P2.

Council asked questions of clarification.

Sandra Dimatteo, 103 Homestead Dr. - expressed concerns with stormwater drainage and management, flooding issues and damages, current homes in phase one are experiencing issues with flooding, drainage and the sump pumps are constantly running. Requested it be moved back from the property line to allow for better drainage.

Ken Burr, 23 Riesling Dr. - spoke to the loss of trees along Line 2, the loss of birds and recommended another study to examine the nesting and bird species being affected, flooding issues, construction equipment on the roads both the traffic and the potential damage, traffic on Frontier Dr. and Line 2, concerns with the fencing dividing the subdivision.

Neil Boyer, 49 Frontier Dr. - discussed concerns with the construction equipment accessing the site, increased traffic, flooding, storm water management and the removal of the trees.

James Webber, 54 Frontier Dr. - agreed with the statements made before him and added concerns with disturbing the wildlife, and the volume and safety of traffic surrounding Crossroads school.

Blake and Brenda Quies - agree with the comments made by those before them.

Carl Peterson, 16 Riesling Dr. - concurs with the comments made by those before him and spoke to the environmental impact. Discussed how the environmental assessment is deficient, tree plantation is home to numerous migratory birds, assessment does not reference the Migratory Birds Convention Act, Endangered Species Act or Fish and Wildlife Conservation Act.

Joanna Dayaram, — concerns with cash in lieu of parkland, protection of the tree canopy, claims clauses being put into buyers purchase agreements that prevent them from raising concerns with tree removal and environmental impact to Council, concerns with tree plantation and preserving wildlife.

Mary Beccario, 1504 Concession 6 Rd - agreed with the comments made before her, expressed concerns with tree removal, increased traffic, speeding and the safety of children and pedestrians in the neighbourhood.
