## 6. DELEGATIONS

#### 6.1 Jim Collard - Community School Alliance

Jim Collard, Representative to the Community Schools Alliance (CSA) on behalf of Council provided a brief background on the CSA to deal with local school boards. Mr. Collard further provided what the CSA tries to achieve. He was before Committee to ask for approval of a draft motion to be forwarded to the Premier regarding the RNEF and moratorium on accommodation reviews and school closures. Mr. Collard answered questions from the Committee.

## 6.2 Gerry Kowalchuk - Queen & Mississauga Gateway Project

Gerry Kowalchuk was before the Committee to discuss the Queen & Mississagua Gateway Project and stated that the drawings are now complete with construction set to proceed in September. He provided a letter of recommendation for Aldershot Landscape Architects and stated that their quotation was within budget. Mr. Kowalchuk answered questions from the Committee.

## 6.3 Tony Visca - Pedal Pub

Marlo Saganski, General Manager spoke on behalf of Mr. Visca of the Pedal Pub. Ms. Saganski was before the Committee to seek approval of a new route for the Pedal Pub. She stated that they have listened to concerns and addressing them, they have also added a slow moving vehicle pass with caution sign to the bikes. Ms. Saganski answered questions from the Committee.

#### 6.4 Richard Mell - Electric Kickscooters

Richard Mell, Grape Escapes was before the Committee to request consideration of the Town running a pilot program and passing a by-law to permit kick scooters within the Town limits. He provided an electronic presentation and explained that there is currently a provincial pilot project with many restrictions but the municipality must have a by-law to permit there use. Mr. Mell answered questions from the Committee.

## 7.1 6.1 Community School Alliance

Whereas all students should have the opportunity to attend elementary
and secondary school in their home community.

Therefore, be it resolved that:

1. The province increase the Rural and Northern Education Fund (RNEF) to \$50 million;

- Should the current moratorium on accommodation reviews and school closures be lifted, we ask that the moratorium remain in place for schools that qualify for the RNEF until a thorough review of the education funding formula is completed;
- Before templates required by the 2018 Pupil Accommodation Review Guideline (PARG) are developed, there be consultation with school boards and community groups including the Community Schools Alliance.

AND FURTHER that staff co-ordinate meetings with the School Boards to discuss the need for new schools in our community, both high schools and elementary schools.
