**A BY-LAW TO AMEND BY-LAW NO. 2025-067 BEING A BY-LAW TO ESTABLISH FEES AND CHARGES FOR THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE**

**WHEREAS** Sections 8, 9 and 11 of the *Municipal Act, 2001*, S.O. 2001, c.25, authorize a municipality to pass by-laws necessary or desirable for establishing and requiring the payment of fees and charges for information, services, activities and use of Town property;

**AND WHEREAS** Section 391 *Municipal Act 2001*, S.O. 2001, c. 25, as amended, provides for a municipality to pass by-laws imposing fees or charges on persons for services and activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control;

**AND WHEREAS** Council enacted By-law No. 2025-067 to establish fees and charges for services, activities, and the use of Town property;

**AND WHEREAS** Council deems it necessary and desirable to amend By-law No. 2025-067 to add a schedule of fees respecting Special Events Permits;

**NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE HEREBY ENACTS** as follows:

THAT By-law No. 2025-067 is hereby amended by adding a new appendix as follows:

1. Appendix "VIII" – Special Events Permit Fees
2. THAT Appendix "VIII" attached hereto shall form part of By-law No. 2025-067.
3. THAT all other provisions of By-law No. 2025-067 shall remain in full force and effect.
4. THAT this By-law shall come into force and take effect immediately upon being passed.
