Thank you for the opportunity to delegate. Our interests are related to policy in the Estate Winery section of the official plan, specifically, Policy #2.2.7.2 and 2.2.7.3.d

These policy changes are important because...

1. We are a farm-first industry, local-fruit matters. Global warming & climate uncertainty impacts YOY grape tonnage
2. Every bottle of Ontario VQA wine sold in the province generates \$98.20 in added value to the Ontario economy. This includes significant contributions to tourism, agricultural jobs, and tax revenue.
3. Strong Regulation & enforcement already in place by the AGCO
4. As currently written, the Official Plan limits future incoming capital investments with both existing properties as well as new entrants.

Based on this I would ask that council refer these specific policies back to staff to change the verbiage to the following:

Estate Wineries 2.2.7.2

We appreciate that Council is taking the time to complete a wholesome review of the policies.

We respectfully request that staff refer to the Winery Review as an On-Farm Diversified Usage Study to acknowledge this is a comprehensive review of breweries, distilleries and wineries.

Estate Wineries 2.2.7.3.d
