- Water levels projections
- Reconstruction of pathway for vehicle access
- Rain garden at the storm outlet
- GIS Mapping and Modelling

Staff advised that they would return to Council with report recommending the implementation of a feasibility study prior to budget deliberations.

III. Community consultation with local residents/businesses on the possibility of a process to encourage replacement of single-use plastics with more environmentally friendly products.

IV.Anticipate costs and timing for implementing the strategy identified above.
