and review and approval of the same by the Town and the Niagara Parks

Commission.

The effect of this By-law is to rezone the property to remove the Holding ("H")

Symbol from the property for all uses except a "restaurant" use, such that only a

"restaurant" use will continue to be restricted by the remaining Holding ("H")

A BY-LAW PURSUANT TO SECTION 34 OF THE PLANNING ACT, BEING A BY-LAW TO AMEND BY-LAW NO. 500WU-15, BEING A BY-LAW TO AMEND BY-LAW 500A-74, AS AMENDED, ENTITLED A BY-LAW TO REGULATE THE USE OF LAND AND THE CHARACTER, LOCATION AND USE OF BUILDINGS AND STRUCTURES THEREON.

**WHEREAS** the Town of Niagara-on-the-Lake Council is empowered to enact this By-law by virtue of the provisions of Section 36 of the Planning Act, R.S.O. 1990, c. P.13, as amended;

**AND WHEREAS** the Town of Niagara-on-the-Lake Council did approve By-law No. 500WU-15 on July 27, 2015, which imposed a Holding ("H") Symbol on certain lands within the Town of Niagara-on-the-Lake.

**AND WHEREAS** the Owner of the lands has now met the requirements for partial removal of the Holding ("H") Symbol from the lands.

**AND WHEREAS** the Holding ("H") Symbol shall continue to apply to the property for certain land uses until such time as the Owner has met the remaining conditions to removal of the Symbol.

**AND WHEREAS** this By-law conforms to the Town of Niagara-on-the-Lake Official Plan.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE enacts as follows:

- 1. Paragraph 8 of By-law 500WU-15 is deleted in its entirety and replaced with the following:
  - "8. Development of the lands for a "Restaurant" use shall only be permitted upon removal of the Holding ("H") Symbol. Prior to the removal of the Holding ("H") Symbol from the lands, the applicant shall complete a traffic impact study to identify and address impacts on the Niagara River Parkway, to the satisfaction of the Niagara Parks Commission and the Town of Niagara-on-the-Lake. The study must consider context, travel demand, evaluation of impacts, site access, circulation and remedial measures."
- 2. That the effective date of this By-law shall be the date of final passage thereof. READ A FIRST, SECOND AND THIRD TIME THIS 10<sup>th</sup> DAY OF JUNE, 2019.
