BY-LAW NO. 4308AL-21

A BY-LAW TO AMEND BY-LAW NO. 4308-09, AS AMENDED, BEING A BY-LAW REGULATING TRAFFIC AND PARKING ON TOWN ROADS.

WHEREAS The Council of The Corporation of the Town of Niagara-on-the-Lake approved By-law No. 4308-09 on the 8th day of June 2009;

AND WHEREAS Section 11 of the Municipal Act, R.S.O. 2001, Chapter 25, authorizes the Council of a Municipality to pass by-laws respecting highways, including parking and traffic on highways;

AND WHEREAS Municipalities may pass by-laws under the provisions of the Highway Traffic Act, R.S.O. 1990, c H8;

AND WHEREAS Council adopted the recommendations contained in Corporate Services Report CS-21-026 to approve amendments to the by-law to permit sections with regard to overnight parking.

AND WHEREAS Council adopted recommendations to add new parking prohibitions to King Street and Turntable Way.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE enacts as follows:

1.

That By-law No. 4308-09, as amended, be further amended by adding Overnight Parking as Section 205.01.11 as follows:
- 205.01.11

Overnight for a period longer than 8 hours at any one time, in or beside Town Parks.
2.

That By-law No. 4308-09, as amended, be further amended by adding Overnight Parking as Section 205.02.16 as follows:
- 205.02.16

Overnight for a period longer than 8 hours at any one time, in or beside Town Parks.
3.

That Schedule “C” (Park Prohibited) attached to By-law No. 4308-09, be amended by adding the following:

This By-law shall come into force and take effect immediately upon the passing thereof except where signs must be erected, in which case the signs must be erected and the By-law finally passed before those clauses shall come into effect.
