## Explanation of the Purpose and Effect of By-law 500XO-20

The subject lands are a parcel of land described as 1074 Line 7 Road, Niagaraon-the-Lake, more particularly described as PT LOT 56, now in the Town of Niagara-on-the-Lake.

#### <u>Purpose</u>

The purpose of this By-law is to rezone the portion of the property (Part 2) in agricultural production to prohibit the construction of a new dwelling, as well as recognize a reduced lot area and lot frontage. The portion of the property containing the existing dwelling (Part 1) will remain Rural (A). The proposed Zoning By-law Amendment is required to fulfil a condition of consent to sever a surplus farm dwelling (File B- 11/19).

### <u>Effect</u>

The effect of this By-law is to rezone Part 2 of the subject lands to "Agricultural Purposes Only (APO) – Site Specific Zone" with site specific provisions for reduced lot area and lot frontage.

A BY-LAW PURSUANT TO SECTION 34 OF THE ONTARIO PLANNING ACT TO AMEND BY-LAW 500A-74, AS AMENDED, ENTITLED A BY-LAW TO REGULATE THE USE OF LAND AND THE CHARACTER, LOCATION AND USE OF BUILDINGS AND STRUCTURES THEREON.

**WHEREAS** the Town of Niagara-on-the-Lake Council is empowered to enact this By-law by virtue of the provisions of Section 34 of the Planning Act, R.S.O. 1990, c.P.13, as amended;

**AND WHEREAS** this By-law conforms to the Town of Niagara-on-the-Lake Official Plan.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE enacts as follows:

- Schedule "A" of By-law 500A-74, as amended, is further amended by changing the zoning of the subject lands identified on Map 'A' (attached to and forming part of this By-law) from "Rural (A) Zone" to "Agricultural Purposes Only (APO) Zone – Site Specific Zone".
- 2. That Subsection 21.A, Special Exceptions of By-law 500A-74, as amended, is hereby further amended by adding the following:

### <u>1074 Line 7 Road</u>

In lieu of the corresponding provisions of Schedule F to Zoning By-law 500A-74, as amended, the following provisions shall apply to the lands zoned "Agricultural Purposes Only (APO) – Site-Specific Zone" shown on 'Map A' attached hereto:

- minimum lot area of 2.99 hectares (7.39 acres)
- minimum lot frontage of 16.4 metres (53.8 feet)
- 3. That the effective date of this By-law shall be the date of final passage thereof.
